Expectations for Training Course:

1. Puppy Class (8 weeks-6 months of age) will learn effective potty training, importance of nutrition and vet visits, commands such as sit, down, stay, loose leash walking, recall, focus, leave-it, and we will go over any concerns with problem behaviors (jumping, barking, etc.) The class will meet once a week for 6 weeks on Tuesday nights at 7:00 pm for one hour approximately. Fee for this course is **\$120** and is expected in full before the beginning of the first session.
2. Basic Class (6 months and older) will learn and be consistent in sit, down, sit-stay, down-stay, recall (at varying distances and with distractions), focus, leave-it, loose leash walking, heel, and any problem behavior concerns will be addressed. The class will meet once a week for 6 weeks on Thursday nights at 7:00pm for one hour approximately. Fee for this course is **\$120** and is expected in full before the beginning of the first session.

TERMS AND CONDITIONS:

1. Owner understands that the trainer is responsible for training the owner to train the dog. The trainer is not responsible for the dog's behavior during or after classes. The owner understands that without full cooperation with the trainer and consistent reinforcement the dog will not get trained.
2. The owner may postpone any of the lessons provided a 24 hour notice is given to CJ's Canine Country Club.
3. The owner may choose to withdraw the dog from training classes, however once the classes have begun all fees are non-refundable.
4. Owner understand that they are responsible for bringing and purchasing all required equipment to every class that the trainer has recommended for training.

Puppy Class: Please bring a standard buckle collar (no slip/choke collars), training treats, 6 ft leash.

Basic Class: Please bring a slip collar, 6 ft leash, and training treats.

5. I _____ as the legal owner of above mentioned dog(s), having carefully read and fully understanding this agreement, do hereby waive and release CJ's Canine Country Club and the trainer Breanna Hough from any and all liability of any nature, for injury or damage which my dog or I may suffer, including but not limited to, any injury or damage from the action of any dog. I assume the risk for such damage or injury that occurs during training sessions, or any other function of the training organization, or on the grounds and surrounding areas.

In acceptance of this training membership by Breanna Hough, I _____ agree to indemnify and hold harmless Breanna Hough and CJ's Canine Country Club from any and all claims, or claims by any member of my family or any other person accompanying me to any training session, or function of the training organization, or while on the grounds and the surrounding areas as a result of any action by any dog, including my own.

I _____ also understand that attending the classes is not without risk to myself, family members, accompanying friends, or my dog because I may be exposed to dogs that are difficult to control and even handled to the best of any persons ability may still cause injury.

6. This training agreement represents the full and only agreement between the parties. The terms and conditions set in this agreement cannot be modified or changed in any way. Any addendums or alterations to this agreement will not be valid or binding, nor will they affect the validity of any non-altered portions of this agreement unless signed by both parties.
